By selecting the “I Accept” button, you are signing this Agreement electronically. You agree your electronic signature is the legal equivalent of your manual signature on this Agreement. By selecting “I Accept” you consent to be legally bound by the Thanks Holdings’ terms of use (the “Terms of Use”). You consent to conduct business electronically with Thanks Holdings and certify that the number/information entered within this account application is your correct Taxpayer Identification Number and that you are a U.S. person (including U.S. Resident Aliens).

You must also have access to a printer and/or the ability to download information, in order to keep copies of the electronic agreements and disclosures for your records. You are responsible for installation, maintenance, and operation of your computer, browser and software. Thanks Holdings is also not responsible for computer viruses or related problems associated with use of an online system.

**Non-Acceptance** – If you do not provide your electronic signature and consent to conduct business electronically, you will not be able to proceed with opening your account(s) online.

**Communication** – To receive correspondence regarding your Thanks Holdings account(s), please provide your e-mail address and update us promptly should your email address change.

**Applicability** – By agreeing, you are also providing Thanks Holdings with your electronic signature and consent to the electronic delivery of all disclosures, agreements, change notices, terms and conditions and any other document required during the course of your relationship with the Company.

**Monthly Billing** – Membership fees are collected each month with a credit or debit card maintained on file with Thanks Holdings. Affiliates may make adjustments to their monthly subscription in the back office of the Thanks Holdings website.
